<u>Large Spills</u>: Stop the flow of material. Soak up all liquid with dry sand, earth or Speedi-Dry. Dispose of recovered material. Flush area with water. Clean area with soap and water.

<u>Auto Decomposition</u>: If pH exceeds 4.0, there is the possibility of foaming and/or expansion of the Material. Tanks should be kept clean, sealed (to prevent water intrusion), and vented. Vents should be fitted with appropriate filter to prevent mold spores from contaminating the material.

<u>Handling</u>: Avoid contact with skin and eyes. Provide adequate ventilation. Wear appropriate personal protective equipment. Observe good industrial hygiene practices. Wash contaminated clothes before reusing.
